**To All Teams playing at the Roosevelt Fields (Modesto fields 1 & 3) –**

**Due to ongoing events and recent altercations, access to Roosevelt Fields from the Roseburg Shopping Center will no longer be available effective December 17, 2008. On Tuesday Dec. 16th, a meeting between Roseburg store owners, Roseburg property management, Modesto City School Officials, Norm Zelones (Deputy Commissioner), and Stuart Kaplan (Fields Coordinator) was held to discuss numerous complaints about the use of space between Roosevelt Jr. High and Roseburg Shopping Center. More notably, recent confrontations between shop owners and parents/coaches that have become verbally abusive and vulgar will not be tolerated. While the actions of some were unintentional, steps need to be taken to mend our relationship with the tenants of the Roseburg Shopping Center. We are asking that coaches, parents, players, and guests that you no longer park in the Roseburg Shopping Center to access Roosevelt Jr. High fields, otherwise vehicles could or will be towed away=2 0at the owners expense. Gates along Orangeburg Rd. and behind Roosevelt Jr. High (next to the blacktop) will be open for your convenience. Park around those areas only.**

**We have been given a second chance, and we need to make the most of that opportunity. If there are any infractions of any type, our permit for the use of Roosevelt Fields will be lost for an indefinite amount of time. Even worse, Modesto Youth Soccer Association, Ajax United, and Modesto Ajax United Football could be denied permits to use other Modesto City School fields.**
